- Forest reported that all ISCAT materials were posted timely to HSAG ftp site. HSAG began its review of materials and selected CEI, CMHCM and Saginaw as the source information and EMR demonstration CMHSPs for review. Thank you for taking the time to review a common ISCAT and provide feedback.
- Forest posted the updated FY21 BH-TEDS specifications and the current compliance report from Carol Hyso. He asked that ITC members look at them to keep track of changes and improvements needed.
- Shyam posted the hospital NPI error file (HRA report). Process is to review the file and correct the reported NPI and/or register in CHAMPS and resubmit the encounters.
- Steve G. provided an update to ITC members regarding the status with HIE processes. Huron CMH is in the validation phase, all others are in production. ITC members can discontinue posting the LOCUS file in BOX except for CEI as it awaits a direct exchange using FIHR. Steve will request an entire file from ITC members in a future month to look for exceptions.

Forest reported that Leslie and MSHN were supporting an extension or change to the process as it was not possible to complete accurately by July 2.</li> <li>• Shyam reported that current year file processing for encounters and BH-TEDS is going well and everything is reported to current.</li> <li>• No update because there was no CIO forum meeting in May.</li> <li>• Joanne reported that CEI was moving into the testing phase for BH ADT submission. She is hoping that the process is production ready in July. Doug reported that even though his project manager had previously advised that the BH ADT module would not be available until August, he found out recently that it is ready. Other ITC members may be able to start the testing process for BH ADTs ahead of schedule.</li> <li>• Open discussion about CC360 API integration. MSHN continues to pursue this for SUD providers and is testing the MFA process.</li> <li>• Steve informed ITC members that the REMI BH-TEDS report will remain as is, this is based on ITC member feedback. Doug and Brett support that it is working as intended.</li> <li>• Joanne announced that the validation reports for BH-TEDS that CEI developed under contract for MSHN are available.
