
About this Guide

Michigan State Appellate Defender Office and Criminal Defense Resource Center offers a Reentry Workbook This book gives information on how to get support after incarceration. SADO's Project Reentry started in 2016 to meet the needs of clients returning home after long stays in jail or prison.

<u>Safe and Just Michigan</u> We support people affected by the criminal justice system through expungement clinics and other helpful programs.

Northwest Initiative-Advocate, Resources, Re-Entry Outreach

(ARRO) program offers funding for ID's and bus passes. To qualify, you must have spent at least 6 months in jail or prison or been released in the last 60 days, and not be currently receiving other reentry services.

Identification and Vital Documents

State-issued identification (ID) or Driver's License

You need a state ID or driver's license for work, housing, and services. If your license was suspended or taken away, contact the Secretary of State to find out how to get it back.

Proof of Incarceration

You may need papers that show you were in prison or jail. Ask your parole officer for this document. You can also request copies at the Criminal Justice Information Center

Identification and Vital Documents

Birth Certificate

Search online for "Where to Write for Vital Records." Sometimes, a prison photo ID with discharge papers may also be accepted.

Social Security Card-Replacement
Go to your local Social Security office to
apply in person. Bring original documents,
such as:

- Birth certificate
- Hospital record of your birth
- Driver's license/State ID
- Prison ID (often accepted)

A Helpful Checklist

- ✓ Go to the Secretary of State to get a state ID or driver's license
- Check what you owe for court costs and fines, and make a plan to pay them
- ✓ Go to a MDHHS office to apply for help
 - Food benefits MI Bridge Card
 - Change your Medicaid/Medicare status from "suspended" to "active"
- ✓ Go to the Social Security Office, and if eligible, apply for: Social Security Retirement Benefits, Supplemental Social Income (SSI), or Social Security Disability Income (SSDI)

- ✓ Obtain a cell phone, if you need assistance contact <u>Assurance</u>
 <u>Wireless</u>
- ✓ Find a doctor and dentist
- ✓ Set up a bank account
- ✓ Set up an email account
- ✓ Obtain a library card, libraries are a great resource for computer access
- ✓ Find employment; meet with an agency that assists with employment or contact a staffing agency
- ✓ Become involved in community or spiritual support groups

TRANSPORTATION SERVICES



It is helpful to have this information when calling:

- Your name, Medicaid ID number and date of birth
- The address and phone number of where you will be picked up
- The address and phone number of where you are going
- Your appointment date and time
- The name of your doctor or medical office


