<p>JOINT – 1915(I) Update</p>	<p>All current recipients of 1915(I) services are required to be entered in the WSA prior to 10/1 to be “grandfathered” in. After 10/1, WSA approval will be required prior to receiving any 1915(I) services. MSHN is currently only at about 28% completion compared to the number of eligible beneficiaries in our region.</p> <p>Reviewed enrollment data as of 6/1/23 with 6/12/23 update. Discussion regarding challenges. There have been challenges with the WSA and queue flow. It can take a long time to see the enrollment go through. Discussed tracking of these. Susan Richards from The Right Door shared their report and offered to share the template with others. Thank you, Susan!</p>

<p>JOINT – Youth Mobile Crisis Related Training</p>	<p>Gauging interest in a regional training for youth mobile crisis/children’s ICSS.</p> <p>Gwenda Summers (CEI) discussed having a staff to train for youth mobile crisis/children’s ICSS. There was interest across the region. Cost will be \$145 per training participant.</p>

JOINT – Child Welfare Clinical Review	<p>Increased number of requests from MDHHS for clinical review/case consultation meetings primarily related to child welfare cases. MSHN will be drafting a regional policy/procedure in an attempt to structure this process. Discussion around structure for meetings, regional process, etc.</p> <p>Discussion around how there needs to be a clearly stated goal/objective up front from DHHS. If it is information gathering, there has to be a reason for it and it can be done by email, then if a meeting is needed it can be scheduled. At the end of the meeting, there should be discussion of how to bring it back to the local level goals/actions. Would like a clear outline of what to expect as reasonable intervention/support from MDHHS.</p>

JOINT- MiCAL Referrals and Feedback	<p>Seeking input regarding if referrals are being received through MiCAL. Some CMHSPs reported they are not receiving any referrals; system may not be working as intended.</p> <p>Discussion of concerns. MiCAL has not been notifying the CMHs consistently when people call. MiCAL stated they will not tell the CMHs a consumer called unless the consumer explicitly tells them to. Creating a lot more work for the CMHs. Would like advocacy to reduce silos and barriers for people.</p>

JOINT – Regional Guide for Authorization of CLS	<p>Topic from CMHCM- "Developing a regional guideline that explains when you would no longer approve CLS in a person's home and you would look at a residential setting instead. Basically a guideline around CLS vs Residential placement what the expectations are for 24/7 CLS being provided in an independent setting."</p> <p>There is some interest in this project to discuss how they have been addressing it thus far, and to create guidelines or potential best practices.</p>
