Recipient Rights are the rights guaranteed by State and Federal laws and promulgated rules. Each licensed SUD program must comply with core recipient rights competencies. This training will review the expected policies/procedures of recipient rights, the role of a Rights Advisor, what it means to coordinate the recipient rights program, how to investigate a recipient rights complaint, and the necessary materials provided to program recipients.
