# STATE OPIOID RESPONSE (SOR)

The State Opioid Response (SOR) grant was awarded to MSHN on December 1, 2018 and will fund prevention, treatment, and recovery efforts throughout the 21-county region for two years (FYs 2019 & 2020). These efforts include services/programming aimed at reducing treatment gaps for individuals living with substance use disorders, specifically opioid use.

MSHN's SOR initiatives include:

- 1) Implementation of Youth/Family-oriented Prevention Evidence-based Practices (EBPs);
- 2) Overdose Education & Naloxone Distribution (OE/ND) with Harm Reduction;
- 3) Recovery Housing;
- 4) Mobile Care Unit; and
- 5) Peer Recovery Coaches in FQHCs & Urgent/Primary Care Centers with SBIRT.

MSHN also received funding to conduct GPRA assessments and other administrative duties related to implementation of and reporting on the overall project.



# PREVENTION

- \$100,000 per year for two years
- 3 curricula to choose from:
  - Guiding Good Choices (parenting ed)
  - Project Toward No Drug Abuse (youth ed)
  - **Prime for Life (youth ed)**

**Current State:** Prime for Life expanded in Hillsdale & Saginaw Counties. MSHN is currently seeking providers interested in expanding and/or adding one or more of these programs to their workplans. *Interested providers must minimally demonstrate a community need, capacity, collaboration with the local prevention coalition.*



OE/ND

- \$100,000 per year for two years, to include:
  - Naloxone kits (\$67,500 per year)
    - New distribution hubs: bars, supermarkets, restaurants/fast food, schools/unis, health departments, TiPS/TAMS trainings
  - Needle clean-up kits
  - Medication lock boxes, disposal bags, community-based collection boxes
  - Immunizations (on mobile care unit)
  - Infectious disease education (on mobile care unit)
  - Other print materials to support OE/ND activities

**Current state:** over 200 kits purchased, should arrive by 4/1/19 for distribution. Presenting at IOAPI on 3/20/19 and at SUD Provider Meeting on 3/21/19 to discuss additional implementation ideas.



## RECOVERY HOUSING

- \$130,000 per year for two years
- Funding can be used for CAIT licenses, minor repairs/improvements, necessary furnishings, but no capital projects
- GPRA required

**Current state:** MSHN has granted funds to three providers to provide minor repairs to existing recovery homes, as well as household goods and supplies (e.g., linens, beds, lighting, etc.) and will consider others as funds are available.



## PEERS IN FQHCS

- \$130,000 per year for two years
- Add peer recovery coaches in primary/urgent care settings, as well as FQHCs and other sites

**Current state:** Partnering with Peer360 to expand the availability of peer recovery coaches in the region. Shiawassee County now has a coach with dedicated lobby hours at Recovery Pathways in Corunna on Mondays, Tuesdays & Wednesdays, at the Safe Center in Corunna on Thursdays, at the YMCA in Owosso on Fridays; this coach will also begin support groups at RP & SC by mid-February. This coach also participates in drug court and community-based coalitions.

In Arenac County, a new coach was hired, with the coach will follow up with List, Arenac BABH & Sterling Health Center to finalize implementation logistics (March/April 2019). The new coach will begin groups on April 1 and will also participate in drug court and community-based coalitions.



## MOBILE CARE UNIT


- \$460,000 per year for two years
- Required staffing on the mobile care unit:
  - Recovery Coach
  - Counselor
  - Driver (if needed, could be Recovery Coach)
  - Nurse
- In-Unit Requirements:
  - Restroom for urinalysis
  - Intake/scheduling area
  - Confidential counseling room



## MOBILE CARE UNIT

- Required services
  - Overdose education
  - Naloxone refills
  - Counseling/therapy
  - Physical health screens
  - Telehealth
  - Needle clean-up kits (SOR-2 funds)
  - Infectious disease education (SOR-2 funds)
  - Immunizations (SOR-2 funds)
  - Suboxone

**Current state:** an RFP for SUD Mobile Care Unit Services was issued on March 7, 2019 and proposals are due on April 12, 2019.
