✓ **KEY DECISIONS**

- SoM is sending Medicaid Redetermination lists and names to MSHN on a month-to-month basis, consisting of those for whom they cannot auto-determine re-eligibility.
- EQI files were submitted 5/2 to CMHs. There are no requirements to send anything back. Some CMHs have run their own validity but have not heard from their finance departments.

	<ul style="list-style-type: none"> • SUD directors had been discussing whether 5515 meets 42CFR part 2 standards, hence the inquiry and request for input. • CEI's IT policies and procedures were received and handled by Sandy and Amy. • CIO Forum notes are uploaded to BOX. Concerns on feedback/assessments for a State-contracted vendor system that no one has yet to see, are ongoing, as mentioned in last meeting. • Concerns over the lack of length and depth of the CIO forum were raised. • There is confusion over Milliman's 5/5 YTD Savings Estimate document, revenue numbers and recent rate adjustment as to which CMHs, if any, are facing a shortfall. TRD informed the council that updated revenue numbers from Milliman show that most of our CMHs are not operating in the red. • CCBHC – CEI reports that the mild to moderate measures did not include their non-CCBHC cites.
