2. Case Consult Process (Voluntary Participation 12:00PM-1:00PM)

Related Documents:

- i. **Background:** Recent case in Huron county for discussion. Issue of hospitals denying despite acute care need. Has co-occurring needs.
- ii. **Questions:** The issue of hospitals denying individuals appropriate for inpatient level care was taken to Dr. Pinals. Has there been any update?
- iii. **Discussion:** Agreement that further neurological workup is needed to determine if individual suffered a brain injury. Suggestion that CMHSPs can participate in Great Lakes Health Connect (GLHC) HIE in order to easily access hospital system lab results, etc. Many coordination of care issues persist with health systems still refusing to share medical records without written patient consent, despite established care relationship and need for coordinated care between providers (permitted without a release by HIPAA and Michigan Mental Health Code)
- iv. **Outcome:** MSHN will obtain additional information about access to GLHC for CMHSPs who might be interested in participating in the HIE

3. Diabetes Monitoring Performance Improvement Project Update (Sandy Gettel 1:00pm)

- i. **Background/Question:** MSHN quality manager Sandy Gettel will provide updates on the Diabetes Monitoring PIP including current regional performance for 2019-2020
- ii. **Discussion:** Concerns that if point-of-care testing is being done at the primary care office or FQHC it is most likely not being captured in claims data based on how the office visit is being billed. Additionally, individuals with dual CARE/CAID are only able to have the service paid for once every 12 rolling months so they may not be captured in the calendar year measurement period.
- iii. **Outcome:** MSHN to provide information on allowable set of billing codes for the measure (HEDIS Specs). Ask health plans how providers are reporting these services.

4. Draft Population Health Plan

- i. **Background/Question:** The Population Health Plan is being updated and MSHN is asking for medical director input.
- ii. **Discussion:** Several recommendations offered related to minor revisions (clarification of data source for a graph, etc). Substantive suggestions noted in body of document for edits.
- iii. **Outcome:** Overall support for the draft changes as summarized in the change document and discussed at today's meeting. Medical Directors will provide additional feedback (if any) to Skye via email by 8/15/20. Plan will then move to CLC, QIC, and Operations Council for review/approval prior to board of directors

5. Health Equity Analysis

- i. **Background/Question:** MSHN has completed data and analysis on three integrated health performance bonus metrics reported to MDHHS: follow-up after hospitalization for mental illness within 30 days (FUH), plan all-cause

readmissions (PCR), and follow-up after emergency department visit for alcohol and other drug dependence (FUA). Plans will be incentivized (and the data will be stratified by race/ethnicity) to focus on the reduction of disparity between the index population and at least one minority group.

- ii. **Discussion:** Suggestion to obtain penetration data based on race/ethnicity for each CMHSP
- iii. **Outcome:** Data presented in Equity Analysis will be reviewed locally by CMHSP clinical leaders; CMHSPs will engage local stakeholder input and begin to discuss strategies for reducing disparities where they exist.

6. Core Service Menus for LOCUS and CAFAS

- i. **Background/Question:** Discussion on core service menus and service authorizations.
- ii. **Discussion:** Postponed until next meeting due to time limitations
