- II. **Review and Approve August Minutes, Additions to Agenda**

- III. **MiCARE Open Beds Registry**
 - A. **Background:** MDHHS sent out a communication earlier this week indicated that orientation and onboarding for the MSHN region would occur during October.
 - B. **Outcome:** MSHN is seeking more clarification about what is needed for organizations to onboard. MSHN will distribute additional information to these committees as it is obtained

- IV. **MSHN Priority Measures Q3 Report**
 - A. **Background:** Review regional performance and CMHSP-level performance. Renewed focus on identifying improvement efforts at local level on measures that are performing below standard
 - B. **Discussion:** FUH measure does not include many codes that are specific to CMHSP services in Michigan (T1016, T1017, H0038, etc). CMHSPs that are performing well on Diabetes Screening measure are utilizing nurses and medical assistants to proactively reach out to individuals in need of screening. Many CMHSPs utilizing care alerts in ICDP to track. Reviewed data for IET (Initiation & Engagement for Alcohol & Drug Treatment). MSHN is tracking IET for the entire Medicaid/HMP-covered population as well as

only those who initiated treatment for SUD diagnosis and received a service through MSHN SUD providers or CMHSP

V. MSHN Population Health & Integrated Care Q3 Report

Quarterly tracking that is included in the population health plan. Skye identified a few highlights, including the performance bonus measures. Discussed the FUA measure relative to race/ethnicity.

VI. MCG Guidelines, 25th Edition

- A. Background:** Review changes to MCG. Social Determinant of Health (SDOH) screening now included with behavioral health guidelines
- B. Discussion:** The 25th edition changes are very minor and have no impact on the MSHN regional process for the use of MCG/Indicia.
- C. Outcome:** MSHN will take steps with MCG to update to 25th Edition

VII. Regional Medical Directors Committee

- A. Background:** Review minutes from 9/17/21 RMD Committee Meeting. What additional opportunities exist for collaboration and information sharing between committees? RMD Committee requesting support from clinical leadership to engage and encourage participation of medical directors in RMD meetings as often as possible
- B. Discussion:** There are opportunities for collaboration however regular attendance of medical directors is not needed at CLC as most agenda topics do not include aspects of medical decision-making.
