 - Steve reported that Carol Hyso sent an email of the FY 22 YTD BH TEDS data, and MSHN shows in the yellow for regular and Crisis, seems to be between submission dates?
 - 1915(i) SPA form was discussed. Group agreed that adding the additional data collection for this could be done. Need to know if this data has to be sent electronically to MSHN.

- MDHHS sent out revised BH TEDS error listing.
- PMV Technical Assistance webinar coming on March 28, request invite if needed.
- MDHHS sent out 5093 enrollment file then indicated there were errors in it.

- Getting PIHP Consumer ID is CMHSP EMR – everyone agreed this would be helpful, Steve to pursue further with PCE
- OIG’s New Quarterly Program Integrity Report – has column for TCN to be filled in. This is not available to the CMHSPs currently. 4950 TCN not stored in PCE. MDHHS Recon file only has accepted and currently active records. CC360 extract (5657) has this but it contains records for all service providers.

- New penetration rate reports in the files and folder for this group to review.
- MSHN IT Data & Reporting Analyst position is begin filled, MSHN IT fully staffed.
- Lifeways question for cookies & browser settings – is there a way to stop password save for the EMR?
- CCBHC subgroup met and talked about Saginaw being only a Demo site, not an expansion grantee. Dave is working on submitting some late services and February encounters, now. Wondered if anyone had information about late services and already bundled services? Ability to Pay and not using fee schedule was discussed again.
