• KEY DECISIONS	 CSC members approved the March 20, 2017 minutes as written. There was no April 2017 meeting. CSC members approved the agenda as written. Standardization of Educational Material/Brochures/Forms Across the Region: favorable to the idea but the use of the standardized materials would not be a requirement. CSC/QIC Score Card: The Score Card is used by MSHN to show progress in specific areas. Reviewed and is required to be reviewed on a quarterly basis. BBA Update: new rules related to Appeals and Grievances go into effect on 7/1/17 for new contract providers. CMHSPs must implement the changes beginning 10/01/17 for FY18. Second opinion timeframe requirement was discussed and clarification will be sought. ACA 1557 Updates: MSHN is waiting before moving forward to see if the state gives any more information. 42 CFR Part 2: Updated rules are now in effect. MDHHS Consent Form Updates: There are a variety of issues people are having with the new form. Some people are NOT using the form as it is believed by some to not follow HIPAA rules/law. Open Discussion: Transportation: very limited use of taxi service but public transportation use is common. Customer Service Member Handbooks: SUD Providers should pick up handbooks from their local CMHSP. Prior handbooks should be destroyed and only new handbooks should be given out.
