Provider 2 worked to reduce access barriers to treatment by subcontracting with Griffin Transit to provide transportation as needed to clients. They supported 82 trips over this reporting period. They also worked to expand services to the adolescent population by hosting groups for children and adolescents impacted by substance use disorders and death. In the groups, they had 63 encounters with youth, but did face the barrier of increasing attendance even with advertising. They also supported a part-time adolescent treatment coordinator position to create a thorough intake process and robust treatment program, update current policy manuals, and perform ongoing program monitoring and outreach coordination. They worked with schools to try to promote treatment in lieu of suspension.

No Program/Activity Outcome Foouts for children & adolescents impacted by SUDs overdose and death Foroider 2 was successful in increasing resilience in children and adolescents impacted by SUD by hosting groups for children and adolescents impacted by SUDs, overdose, and death. There were 10 groups held and 63 encounters with youth over this reporting period. There were several groups that did not take place as they did not have any attendance. Provider 21 worked to provide MOUD and group treatment in Tuscola County Jail in addition to disposing of sharps and ordering overdose prevention items for the community. They received two referrals for individuals for MOUD treatment from the jail. They provided 18 groups with 8-10 participants on average for each group. They also disposed of over 450 gallons of sharps in the community. The OSF funds allocated helped to bridge a gap in funding for MOUD medications for the county jail until a new fund source was able to begin in the fall of 2025.
