  - Federal cuts
    - i. Frequent cuts to governmental agencies that affect us (SAMHSA, Medicaid, etc.)
    - ii. Only one that has affected MSHN (equity initiatives) is ARPA funds cut/frozen per AG suing
    - iii. CCBHCs previously had bipartisan support for their expansion, last week learned current draft funding does not expand this initiative
    - iv. Ingham county lost several AmeriCorps staff
    - v. Medicaid cuts will deeply impact FQHCs
    - vi. Rising Voices putting out statements re: xenophobic comments by lawmakers, current house bills, connecting with other organizations such as Planned Parenthood
  - State budget & Advocacy
    - i. Other bills have cropped up in state bills, introduced mandatory sentencing for fentanyl possession, MSHN doing some advocacy
    - ii. Opioid Settlement Fund issues not being used efficiently, more scattershot approach and PIHPs excluded from much discussion

- IDEA Updates
  - i. Upcoming lunch and learns on Trauma, biases in data collection/Evidence Based Practice, extremism/radicalization, racial reparations and the faith community
