- All communications received from MDHHS have either been shared via email or uploaded via FTP.
- MSHN staff have noticed a recent lag between Encounter Submissions acknowledged and accepted. While this does not currently appear to be a problem, we will be keeping an eye out for it.
- After a successful pilot program, MSHN is in the process of implementing the Compliance Software.
- Steve Grulke expects to hear in the next week about the MCG upgrade. Being two revisions behind, we anticipate a double upgrade.
- We received an update letter from HSAG indicating that, after State review of some of our files and documentation, our score had improved. We have received no news on our PMV review since July – we are still waiting for a draft.
- The opportunity to make changes to ITC, specifically for a potentially post-MSHN future, has been introduced and made available for ITC Members.
- The EVV Vendor meetings have all been concluded. The State and HHAX will move forward with the billing process, as is, despite pertinent questions having not been answered.
- There was notably low MDHHS participation during the June CIO Forum meeting.
- A July 14th MichiCANS training was offered to CCBHC members about gaining access to CC360. There was no “why” given for this training, leaving Joanne Holland and other members to speculate that it’s related to Child Welfare and the rule that two screenings cannot be done, leading to the expectation that participants will have to log in to CC360 to see if a screening has already been

	<p>done for an individual. This is currently speculation, as none of this has been made clear by the State.</p> <p>CCBHC:</p> <ul style="list-style-type: none"> As CCBHC transitions away from PIHP oversight, the system and participants are facing the problem of BH-TEDS management. Individuals receiving CCBHC-only services are presently expected to send a BH-TEDS to the State only. If an individual receives co-occurring services, as each CCHBC indicates a significant proportion do, this would require a discharge and re-admit, every time things change. This is widely unpopular and burdensome and arguably defeats the stated purpose of even using a Behavioral Health Treatment Episode Data Set. Additionally, the State does not currently have Beneficiary IDs separate from the PIHPs. Joanne is not optimistic that voicing our concerns to The State about this will yield any actionable consideration, much as it didn't with EVV issues and concerns. <p>BHH</p> <ul style="list-style-type: none"> Jennifer Tucker is building a dashboard report for actionable measures based on CMHA data instead of relying on either CC360 or ICDP There is no DeCIPHR activity presently taking place.
