5- HCBS and Eight IPOS Elements	Discussion on the 8 elements and when behavior treatment plans are required. These HCBS are required to be documented in the IPOS anytime there is a restriction based on identified health and safety needs separately from any Behavior Treatment Plan the individual might have. These requirements apply to restrictions based on medical reasons even when a BTP would not be required. MSHN is reviewing 80-100 plans per month as part of the annual waiver recertification process which has provided good opportunities for feedback to CMH staff who are writing the plans. There continue to be conflicts between HCBS requirements and LARA licensing requirements for AFC homes that can be challenging to navigate. Reviewed a MSHN guidance document outlining when a BTP is required in addition to the 8 HCBS elements in the IPOS.

6- WHODAS 2.0	WHODAS was selected as the statewide assessment tool for individuals age 18+ with I/DD via an expert steering committee consisting of PIHP/CMHSP staff, beneficiaries, assessors, family members, advocates, and MDHHS staff. WHODAS is a 36-item tool and evaluates functioning in multiple life domains. It takes significantly less time to administer than the SIS and it has been rigorously tested for reliability and validity. The steering committee is currently working on developing a guidance manual and it is anticipated that pilot testing and training will occur throughout fall/winter 2025. Implementation is expected to begin in spring 2026. Expanded discussion occurred about other required population-specific assessment tools (LOCUS, CAFAS/PECFAS, MichiCANS)
