- Forest posted the latest report from MDHHS regarding MSHN SIS assessments.
- HSAG will be onsite July 18. ITC members or representatives will need to call in using the ITC conference number. The scheduled time is 11:15am – 12pm. - Forest talked about annual contract evaluation process and requested ITC feedback on two contracts: 1) CEI for processing BH-TEDS and Encounters 2) Netsmart Technologies for CareNet support and use after hours. Forest will post a contract evaluation template and is asking for feedback by July 19th. This feedback will be incorporated into a MSHN contract review process.

	<ul style="list-style-type: none"> • Joanne reported no problems with the 2017 monthly file processing for BH-TEDS and Encounters. Doug mentioned that Shiawassee invited Carol Hyso to come in and talk about BH-TEDS change requirements and to train on field values and use. • Steve reported that the Financial subgroup has reviewed the options for reporting COB and are working toward a recommendation. The MDHHS contract will require the LARA license on transactions for fy2018. Look for more documentation in BOX. • Joe Wager posted a few of the dashboard indicator reports that show detail used in calculations. ITC is reviewing for noticeable differences month to month and year to year. Discussion will occur at the August ITC meeting. • Forest indicated that MSHN has signed an agreement with GLHC to use VIPR. Med Reconciliation use case is in final stages, but MSHN is negotiating a governmental rate because the cost per transaction is too high. • July ITC meeting will be a call-in only meeting and should only go an hour, but will keep the two hour time block from 1-3pm.
