BHH IT subgroup (as time allows) Central, Montcalm, Newaygo, Saginaw, Shiawassee and GIHN • With the cancellation of the May meeting, MDHHS communications for both April and May were forwarded to ITC members via email and/or FTP server when appropriate May's Medicaid closure file should be the last one. • CEI reports that their provider with an invalid NPI does in fact have a valid number, but is not yet registered in CHAMPS, and that they are stuck until their provider finishes that process. • Although the number of dangling admissions do not appear to be going down from the PIHP perspective, multiple CMHSPs report having winnowed their lists

down significantly. CMHCM reports reaching out to MDHHS regarding questions

on their list with no answers received. Attribution errors, acceptance or rejection of an admission or discharge, and other elements are complicating the completion of this process.

- HSAG PMV review documents are due Friday.
- In the FY24 Encounter Recon files for both May and June, BH-TEDS were 100% while only a total of perhaps 20 encounters were off.
- There has been no follow-up to the MiHIN security incident on May 10th.
- A great deal of concern over the Psych Inpatient tiered rates and modifiers has been expressed. Questions such as "What constitutes a "day" if staffing levels, which adjust the tier, change in the middle of the day?" or "How will this change the authorization process?" have gone unanswered. It was noted that this does not appear to be a federal rule. Joanne advocates for Steve to tell the state how much work is going to have to go into this as-is. Modifier collection is expected by 10/1/24 at this point.
- PCE is working on sending the exact copy of admissions records to account for the few missing LOCUS hourly rates. This shouldn't make more work for CMHSPs, but will change records on their behalf.
- TEDS and Encounters submissions have been sent and received without major issue.
- The Authorization Reporting requirement was met with much resistance, and Joanne notes that it doesn't align with CFAP. She also urges ITC members to speak with their CEOs regarding it. Steve does not believe that the topic has made it to Ops council yet.
- The EVV's 837 rollout process has been delayed, and currently requires manual double data entry. It continues to not match the way care is provided in group settings. CEI indicates that they will likely have to hire someone specifically for this task. CMHSPs will need to indicate the vendor that they will use by 7/12/24

CCBHC:

	 There is a new element in the handbook, the "Create Patient List," which should be possible with any software that is ONC certified. Joe Wager indicates that it would be worth examining more closely, given the absence of definition for terms such as "patient." WSA-PCE cross-communication is in process. Receiving WSA information is working, but sending is still on the drawing board. BHH: CMHCM conducted a staff analysis for two of their six counties which indicated positive results. They plan to expand it to their remaining four. So far, all participants indicate comfort with the level and number of people served.
