If any ITC members are missing anything, MSHN can send it on directly by request. Bulletin MMP 23-60 Asynchronous Telemedicine, while available online, will be added to this meeting's folder. No significant delays were noted for MDHHS TEDS and Encounter Submissions. Ron will send an error report next week following this week's submissions, indicating to each CMH who should expect error files. Joanne Holland explained the DMC Review changes with respect to CEI's role in the process: • There are nine new response options for children and youth in the criminal justice referral. o 6 randomly selected consumers will have the 3 data points validated. **✓ KEY DECISIONS** 

- Is there a BH-TEDS record for this client in the last 15 months?
- If client Discharged or Inactive, is there a BH-TEDS Discharge document?
- If client's reported Employment Status is either Full-time or Part-time; is there a 3-digit value (> 0) entered to identify the number of hours in the past two (2) weeks that the individual performed work/tasks?
- A request was made for an extension on time for the contact data spreadsheets. As the request was made by MDHHS late last week with a deadline of today, many felt the amount of time required to complete this to be too short.
  - Additionally, Joanne Holland highlighted several issues and concerns with linking modifiers, in specific orders, to codes for authorization purposes, indicating that this is not how the process works and demonstrates a failure of understanding on the part of the vendors. Joanne will be meeting with the vendor regarding file formats on Friday.
  - Similar concerns about the process include the verification of location for Community Living Supports. Most CLS services take place outside of the home, considered Location 99. The EVV would only be confirming location 12, at the office. Michelle's instructions and the FAQ do not match.
  - The start date of March 1<sup>st</sup>, 2024 has been maintained by the state. Many remain skeptical of this as a realistic start date, given that many specifications still have either not been released or determined.
